BLOCK WATCH SUCCESS STORIES Part 3

The Black Mountain Precinct's Community Action Team regularly builds and promotes Block Watch in order to maximize community involvement. If you've worked with your Community Action Officers or local Block Watch groups, you'll hear a lot of great advice regarding how to make your neighborhood safer. What you don't always hear about are the success stories associated with community involvement. This series focuses on Community Action Officers and their Block Watch/Community success stories.

Block Watch Success Stories (Volume 3)

This month we conclude our three month series titled "Block Watch Success Stories". In this instalment we hear from Officer Andrew Miller regarding his experience how one concerned resident changed his neighborhood. We also hear from Officer Tony Cuciti regarding his experience with a neighborhood group whose passion and commitment to their community created a bond with the police department that's spanned almost a decade.

Officer Drew Miller

In January of this year I was contacted by a retiree who lives in the area of 19th Ave and Greenway Rd. He explained how he wanted to combat the deterioration of his neighborhood. He identified three specific homes that he perceived as needing more attention from the police department. I explained the benefits of an investment in neighborhood Block Watch and he took the initiative to go knock on just about every door in his community in order to gauge interest.

The first meeting was at his home with over 17 neighbors in attendance. Subsequent meetings followed at other homes which allowed me to get a much more comprehensive understanding of their concerns. This enabled me to form a long term plan that activated previously untapped resources. As a result, Turf Mobile Estates Block Watch was formed, encompassing 102 households. With the help of Officer Owsley, at least four problem locations were identified as being hangouts for undesirables. Within a short period of time, and with the help of concerned neighbors, these properties were vacated and cleaned.

Block Watch signs, purchased through grant funds, were installed at specific and strategic locations. These signs helped individuals not invested in the community understand criminal activity would not be tolerated. The progress encouraged more neighbors to get involved and the community now has a direct line of communication to your Phoenix Police Department.

Crime analysis figures showed a 32% decrease in crime in less than six months. When neighborhoods teams up with your Phoenix Police Department, as Turf Mobile Estates did, the results are positive and impactful. There is still work to be done but with the help of concerned citizens like this one, the work is much easier to accomplish.

Officer Tony Cuciti

In the latter part of 2010, I had the distinct opportunity to meet with a group of parents at a local elementary school in the Maryvale area. There is nothing out of the ordinary for a Community Action Officer to receive an invitation to meet and speak about crime in the area, but this meeting was different. To say they were afraid and intimidated by police presence would be an understatement as these residents were negatively influenced by the media. Ultimately,

these parents, grandparents, aunts, uncles, and children met with officers because of criminal elements terrorizing their children and community.

The challenges we faced were to build solid relationships, establish trust and confidence, organize a block watch and provide support for dedicated residents engaged in crime reduction efforts. After a two hour meeting, the decision was made to start a block watch focused on protecting the future of their children. The group quickly formed and became Phoenix Neighborhood Patrol (PNP) certified by the police department. The first ever PNP classes were conducted entirely in Spanish for this group. Volunteers provided daycare, refreshments and weekend classes were never less than fifty participants.

Neighborhood patrols were conducted weekly in the nearby park in conjunction with a Zumba class held three days a week. The participants would exercise for an hour, then patrol the park and surrounding area. The neighborhood became energized, and good people responded to support a cause. With help from Neighborhood Services and Graffiti Busters, a coordinated effort resulted in graffiti removal, parks and fields cleaned, and drug houses eradicated. Several surrounding Block Watch groups participated in group PNP patrols to help the area and lend their knowledge of crime deterrence. Veteran block watchers provided further support and wisdom by helping the group write grants, establish a website and newsletter.

These brave individuals reduced overall crime in the community and built a base of support and trust. Eight years later the group is still going strong and the community benefits from their leadership and pro-police support. Similar to how steel is forged and transformed into shape by careful effort, the relationships between the police department and block watch groups advance steadily and gradually to form a perfect bond.

REPORT ALL OF YOUR VOLUNTEER TIME!!!

Since PNP went live with volunteer.phoenix.gov in August 2016, we have hoped to reduce duplication of effort and paper logs/worksheets. These new improvements continue this effort with the following changes. We hope to have videos up soon for the recent changes to online reporting.

Mileage Reimbursement

PNP members who have a NBW Grant in their neighborhood that has funds for PNP patrol fuel reimbursement we are offering, as an option, beginning this month to record miles and reimbursement documents online. The log sheet has been updated for this. PNP members recording their time for fuel reimbursement this way must enter the beginning and ending odometer readings and license plate number of the vehicle used on their logs. When you are ready to do a reimbursement simply email Brian.kornegay@phoenix.gov the PNP members name and the time frame you are requesting to reimburse and he will email back a report. This report will be signed as becomes your "receipt" for the grant quarterly report. The report double checks the math and calculates the reimbursement total.

If this methods work well it will likely be the required method for the grants awarded in July 2018.

PSVA Participants logging hours

In the past PNP members who also participate in the Presidential Service Award (PVSA) program had to do separate entries for PNP and PVSA. This was a duplication of effort. We have an updated combination log for PNP and PVSA. Detailed instructions went out to the PNP members who are also in PVSA.

PHX C.A.R.E.S.

PHX C.A.R.E.S. leads with services to help those experiencing homelessness find long term solutions.

PHX C.A.R.E.S. sends trained outreach teams, that take the time to build rapport and trust with people on the street, to encourage them to accept the services and resources that are offered to help end their homelessness.

Encampments

Homelessness is not a crime. However, there are a variety of laws and ordinances which govern how space and property are used to promote a safe, healthy community environment. If you are concerned about an encampment in an area not meant for residency or long-term occupation, please let the City know so it can be investigated and addressed as appropriate.

Shopping Carts

The Neighborhood Services Department (NSD) has a program to retrieve abandoned carts from neighborhoods, alleys and public streets. The program encourages retailers to reduce the number of carts leaving their property, therefore limiting potential safety hazards and blight in the community. File a report with the exact location of the cart(s). Carts will typically be picked up within 24 to 48 hours of the call.

Light Rail and Bus Stops

The safety of our bus and light rail passengers is our top priority. The city of Phoenix works with Valley Metro on enforcement and the collaboration of safety specialists to keep our customers safe aboard our transit system.

We encourage riders to report any inappropriate behavior. This includes people who are being loud, rude or harassing, as well as suspicious behavior and criminal activity.

If you see someone breaking the law, please call 9-1-1.

However, if someone is not abiding by the Valley Metro rules of conduct and etiquette, such as lying down on seats, loitering at light rail platforms or bus shelters, please report these instances to a bus operator, or if you're a light rail passenger, report to a security guard, fare enforcement officer, or use the emergency call buttons located on each train and platform.

Neighborhood Assistance

You can help prevent encampments from forming in your alley by keeping it clear of weeds and debris, properly placing trash in the containers, and working with your neighbors to keep an eye on the alley. Learn more about programs through the city to help with neighborhood cleanups.

Neighborhood Specialists serve as city liaisons to residents, answering questions about city programs and services, organizing community meetings and cleanups, and working with other city departments and agencies to provide services.

Property Owners Assistance

How is trespassing related to crime prevention? Trespassing comes up many times in a business setting. Consider the customer who is disruptive or the one you suspect stole from you last time. Don't forget the visitor in your office that is starting to get angry. Dealing with all of these people can be unnerving if you don't know where you stand. Understanding the rules can allow you to determine the outcome of these situations and possibly avoid a violent confrontation. As the owner of a property that operates a business, you may request an Authority to Arrest, which allows Police to trespass individual(s) who do not have your permission to be on your property. The Phoenix Police Department provides guidance on the laws and where to place No Trespassing signs.

How it Works

1. The City receives information about unsheltered homeless through the customer service line at 602-262-6251 or online at [PHX At Your Service](#).
2. Human Services department staff coordinates outreach and engagement for person living in reported encampments with the goal of connection them to housing and supportive services.
3. Human Services and Community Bridges, Inc. (CBI) outreach teams respond 7 days a week from 5 a.m. to 11 p.m.

Outreach teams seek to respond within 3 to 5 days of receiving referral

WHEN YOU CALL 911 KNOW THE 10 W'S

"Call if you can. Text if you can't." was the key message rolled out during a press conference on April 2nd as text to 9-1-1 service capability becomes available for the first time in the greater Phoenix region. If you are in imminent danger and unable to talk to a 9-1-1 operator, you now have the ability to text to 9-1-1. The service goes live following months of collaboration between numerous public agencies and advocates for the disability community.

- **What** - is your location? GIVE EXACT LOCATION
- **What** - happened? WHAT TYPE OF CRIME?
- **When** - did this happen?
- These questions will determine if it is a priority call. Give as much of this necessary information as you can.
- **Was** - anyone hurt?
- **Weapons** - are there weapons involved?
- **What** - manner did they leave or arrive – foot, vehicle, bicycle...?
- **Who** - did it? –Suspect description
- **Where** - did the suspect go? – What direction
- **What** - did the suspect obtain? – type and amount
- **Who** - is calling? – Give your name location and phone number (You can remain anonymous. If you do give your name, the info is redacted from the public record access.)

SIGN UP FOR REVERSE 911 IN CASE OF EMERGENCY

- Getting an emergency message out to those living near a catastrophe can be difficult. In Arizona, there is a reverse 911 system.
- The Community Emergency Notification System helps those managing a disaster send a message to potential victims, alerting them to stay away and stay safe.
- The Community Emergency Notification System is a robo-voice message alert going straight to your phone.
- The system automatically dials the landlines in the area of the active scene, but with landline phones nearly extinct, you must register your cell phone if you want to get the message.

- The system will be able to send text messages out and not only to those who are registered but also to anyone who is near a cell tower where the situation is ongoing.

CRIME TIPS:

FAKE CHARITIES CHARGED WITH EXPLOITING SUPPORT FOR VETERANS

Federal and state authorities take action against groups that cash in off your donations

The letter was designed to tug at the heartstrings — and open the wallets — of anyone who admires veterans.

"For thousands of disabled veterans who served in Iraq and Afghanistan, giving an arm and a leg isn't simply a figure of speech — it's a harsh reality ... Your \$10 gift will mean so much to a disabled veteran," said the letter from Neil G. Paulson Sr., head of a group called Help the Vets, Inc.

There was just one problem: Federal and state agencies say 95 percent of the \$20 million that Americans donated to Paulson's various charities, operating under names including Veterans Emergency Blood Bank and Vets Fighting Breast Cancer, went to fundraising, administrative expenses, and Paulson's salary and benefits. At the same time, Paulson falsely claimed a "gold" rating from GuideStar, a group that evaluates charities.

Paulson has been charged with violating state and federal laws, one of more than 100 actions announced today as part of a sweeping crackdown on [fraudulent veterans charities](#) by the Federal Trade Commission (FTC) and law enforcement officials and charity regulators from all 50 states and the District of Columbia.

The massive joint federal-state effort, focusing on multiple cases of sham charities that bilked consumers out of millions of dollars in donations, also includes a new nationwide initiative to [educate consumers about how to donate wisely](#).

"Americans are grateful for the sacrifices made by those who serve in the U.S. armed forces," FTC Chairman Joe Simons says in a statement. "Sadly, some con artists prey on that gratitude, using lies and deception to line their own pockets. In the process, they harm not only well-meaning donors, but also the legitimate charities that actually do great work on behalf of veterans and servicemembers."

Another target of the crackdown, Travis Deloy Peterson, was charged by the FTC with inventing names of fake veterans charities to persuade people to donate cars, boats and real estate, which he then sold for his own benefit.

Among the names he used were: Vehicles for Veterans, Saving Our Soldiers, Veterans of America, Act of Valor, and Medal of Honor.

Peterson allegedly [made millions of robocalls](#) asking people for donations he falsely claimed were tax deductible. None of the groups was a real charity with tax-exempt status.

In addition to the FTC cases, the states announced [a long list](#) of separate actions against a wide range of charities that fraudulently claimed to help veterans.

The illegal behavior alleged by the states includes fundraisers who stole money solicited for a veterans charity, officials at charities who used donations for themselves, and charities that used deceptive prize promotions in their solicitations or falsely claimed that donations would be tax deductible.

"Scam artists are on the prowl, ready to take advantage of donors who want to help veterans," says Maryland Secretary of State John Wobensmith.

Older Americans can be especially appealing targets to phony veterans charities, says Lois Greisman, associate director of the division of marketing practices at the FTC. "We know older adults are very generous, and some of the scammers have lists and are targeting older consumers," she said.

"The harm here is enormous," Greisman says. "Think of the legitimate charities deprived of money they could put to good use."

The new public education initiative unveiled by the FTC and the states, called "Operation Donate With Honor," is designed to help consumers distinguish between legitimate and fraudulent charities. It [includes a video](#) and other materials on how to research charities, what questions to ask, and how to be aware of tricks scammers use.

One of the tips offered to consumers is to remember, when they are asked for donations, to simply hold off on giving until they have time to think and do some research.

"If they're pressuring you to make an immediate gift, that's a red flag," says Art Taylor, president and CEO of the BBB Wise Giving Alliance. "It's not critical you give at that moment."

Those involved in the public education effort are hoping that publicity about sham charities will not discourage people from donating to worthy charities that help members of the military.

"Educate yourself and continue to give," Wobensmith says. "Just make sure you're giving to reputable charities."

"The vast majority of charitable organizations do good and important work," says Nebraska Attorney General Doug Peterson, who urged Americans to look up charities' records so they can "donate with confidence in support of our military and veterans."

HOW TO MAKE SURE A VETERANS CHARITY IS NOT A SCAM

Use these expert tips to become an informed giver

There are many legitimate charities [helping veterans and military families](#), but it's wise to do your homework before choosing to give.

"Most people think charities are set up to do the right thing," says Art Taylor, president and CEO of the BBB Wise Giving Alliance. "We're trying to get people to investigate before they give. Be proactive, ask questions such as how much money goes to the cause and how exactly the organization helps."

The Federal Trade Commission (FTC) announced a [crackdown on fraudulent veterans charities](#). The FTC, BBB alliance and [AARP Fraud Watch Network](#) suggest these tips to be an informed giver.

DO:

- **Research.** Search online for the charity's name and words like "scam" or "complaint."
- **Check out** the group through organizations that evaluate charities such as [BBB Wise Giving Alliance](#), [Charity Navigator](#), [CharityWatch](#) and [Guidestar](#)
- **Learn** whether the charity is registered with your state charity regulator, something most states require. Go to the [National Association of State Charity Officials](#) (NASCO) to find out.
- **Ask** for the charity's website and address.
- **Ask** what the mission is and how much of your donation goes directly to help veterans and military families.
- **Ask** how many service members and families the group helps.
- **Report** scams to the [FTC](#) or to your state charity regulator through [nasconet.org](#).

DON'T:

- **Give in** to phone call pressure to donate immediately. Check first to make sure the group is legitimate. Think before you give.
- **Give cash**, wire money, or pay by gift card. It's safer to pay by check or credit card.
- **Fall for it** when you're told that by donating you'll win a sweepstakes or prize. That is illegal.
- **Fall for** the suggestion that you made a previous donation that you don't remember.
- **Be fooled by a name.** Just because a group uses the word "veterans" or "warriors," that doesn't mean it's legitimate. The group might be trying to take advantage of your patriotism.
- **Confuse** a charity appeal with a bill and think you have to donate because the solicitation looks like an invoice.



THEFT FROM CARS SCAM

I locked my car. As I walked away I heard my car door unlock. I went back and locked my car again three times. Each time, as soon as I started to walk away, I would hear it unlock again!! Naturally alarmed, I looked around and there were two guys sitting in a car in the fire lane next to the store. They were obviously watching me intently, and there was no doubt they were somehow involved in this very weird situation. I quickly chucked the errand I was on, jumped in my car and sped away. I went straight to the police station, told them what had happened, and found out I was part of a new, and very successful, scheme being used to gain entry into cars. Two weeks later, my friend's son had a similar happening...

While traveling, my friend's son stopped at a roadside rest to use the bathroom. When he came out to his car less than 4-5 minutes later, someone had gotten into his car and stolen his cell phone, laptop computer, GPS navigator, briefcase....you name it. He called the police and since there were no signs of his car being broken into, the police told him he had been a victim of the latest robbery tactic -- there is a device that robbers are using now to clone your security code when you lock your doors on your car using your key-chain locking device..

They sit a distance away and watch for their next victim. They know you are going inside of the store, restaurant, or bathroom and that they now have a few minutes to steal and run. The police officer said to manually lock your car door-by hitting the lock button inside the car -- that way if there is someone sitting in a parking lot watching for their next victim, it will not be you.

When you hit the lock button on your car upon exiting, it does not send the security code, but if you walk away and use the door lock on your key chain, it sends the code through the airwaves where it can be instantly stolen

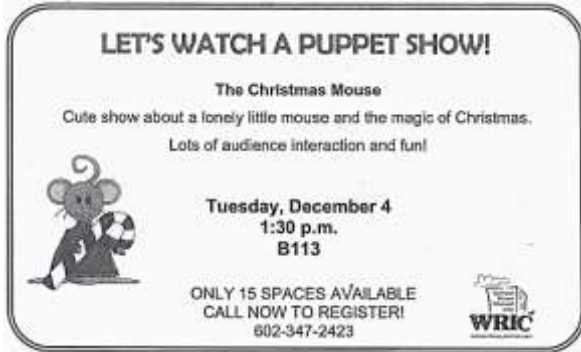

With Holiday Shopping Approaching, Keep Safety in Mind

The Maricopa County Attorney's Office wants you to have a safe and happy holiday season, so for those of you who brave the holiday sales the day after Thanksgiving, we'd like to share some safety suggestions to keep in mind during the holidays and throughout the year.

Shopping and using credit card

- Use only one credit card when shopping so you don't have to chase down multiple cards, if your purse or wallet are taken.
- Put your card away after each use. Don't put it in your pocket, where it would be easy to steal.
- Thieves are looking for people who are distracted, do not place your purse in a shopping cart or set it down unattended, as thieves are waiting to carry it off.
- For practical purposes, your debit card should be treated as cash. If your card information is stolen or compromised, criminals can easily take funds from your checking and savings accounts. In contrast, if your credit card is stolen and used, you can file a report with the credit card company, close that account and get a new card issued.
- Watch out for false advertising or deals that seem too good to be true; do your due diligence and research large purchases.

In the parking lot

- If approached by someone asking for cash, saying they have a broken down car, a sick relative or some other problem; these requests are scams and you should say no or quickly walk away. If you are followed or harassed, return to the store and report the incident to employees or call security.
- Don't be distracted by your cell phone.
- Look for individuals lingering in the parking lot or near doorways
- If you hear someone walking behind you, stop and turn around or wait for others who are walking to their vehicles and walk with them.
- If you are carrying a large number of bags, ask store employees for assistance.
- Rushing to your vehicle if you see something suspicious isn't worth the risk; take the time to be safe.
- If you need to make a trip to your vehicle to drop off purchases but plan to continue shopping, drive your vehicle to a new parking spot.

ADOT gearing up for traffic interchange reconstruction project at Interstate 17 and Happy Valley, Pinnacle Peak roads

Expect to see construction activity near Pinnacle Peak Road this month



The Arizona Department of Transportation is beginning work on the project to reconstruct the Interstate 17 traffic interchanges at Happy Valley and Pinnacle Peak roads. While some construction activity will be underway soon, no major restrictions or closures are scheduled to occur during the holiday season.

This week, crews are scheduled to install a temporary water line on the southbound I-17 frontage road between Jomax and Happy Valley roads. Work will occur between 9 a.m. and 3:30 p.m. through Friday, Nov. 16. The frontage road will be narrowed to one lane and will remain open to traffic.

Starting Nov. 27, lane restrictions are scheduled to begin on the southbound I-17 Pinnacle Peak Road on-ramp in advance of ramp reconstruction work. ADOT will provide updated information about the restriction when it is confirmed. Crews are also scheduled to begin surveying, moving equipment into the construction area and conducting other minor work along roadway shoulders near Pinnacle Peak Road after the Thanksgiving holiday. Last year ADOT announced plans to reconstruct the interchanges to improve safety and traffic flow in this growing section of north Phoenix. The project will include:

- adding an additional general purpose lane on I-17 between Deer Valley and Happy Valley roads
- constructing a tight diamond interchange at Pinnacle Peak Road with two through lanes in each direction; dedicated right- and left-turn lanes; and bicycle lanes and pedestrian walkways
- removing the existing roundabouts at Happy Valley Road and constructing a diverging diamond interchange with three lanes in each direction; dedicated right- and left-turn lanes; and bicycle lanes and pedestrian walkways
- replacing a box culvert on Pinnacle Peak Road.

Work is scheduled to continue through 2020.

I-17 improvements coming, but safety depends on driver behavior

ADOT working on design study for Anthem to Sunset Point area

As the Arizona Department of Transportation advances projects that will add capacity to Interstate 17 north of the Phoenix area, drivers can help improve safety and reduce delays today by avoiding speeding, aggressive driving, distraction from things like cellphones and other behaviors that lead to crashes.



The longest backups stemming from crashes occur most often on weekends, when many drivers take I-17 to and from Arizona's high country.

"New lanes will play a role in improved safety, but driver behavior remains the key," ADOT Director John Halikowski said. "The reality is that a reduction in speeding, sudden lane changes and impaired driving would reduce crashes, closures and frustrating traffic backups along this corridor."

ADOT is conducting an environmental and design concept study scheduled for completion by summer 2019. Initial construction of a third southbound I-17 lane between Black Canyon City and Anthem is planned in 2020.

The Maricopa Association of Governments, the Phoenix area's metropolitan planning organization, has committed \$50 million in its Regional Transportation plan in 2019 and 2020 for design work and the start of construction of the third I-17 lane extending south from Black Canyon City.

ADOT's statewide construction program includes more than \$100 million starting in 2021 to build I-17 "flex lanes" between Black Canyon City and Sunset Point. Construction is expected to take two years.

Flex lanes will operate as a separate two-lane system next to the existing I-17 southbound lanes between Black Canyon City and Sunset Point. Separated by barrier wall, the flex lanes will carry vehicles in one direction depending on traffic needs.

These new lanes will provide flexibility and additional traffic capacity at times when I-17 traffic is heaviest in one direction, including northbound on a Friday or southbound on a Sunday. The flex lanes, with gates or movable barriers at each end, also will help keep traffic moving if a crash or other incident has occurred on the steep, winding section of I-17 north of Black Canyon City.

Driver behavior is the leading factor in crashes along I-17 in the Black Canyon City region. An ADOT analysis conducted for a recent safety project showed that "speed too fast for conditions" was cited by Arizona Department of Public Safety troopers in more than 40 percent of I-17 crashes in that area.

Getting a new license plate? No need to bring the old one back

MVD recommends avoiding an unneeded office visit

PHOENIX – Buying a vehicle that needs a new license plate, or upgrading to a specialty or personalized plate? The Arizona Department of Transportation Motor Vehicle Division is reminding motorists that you don't need to return an old license plate to the MVD.

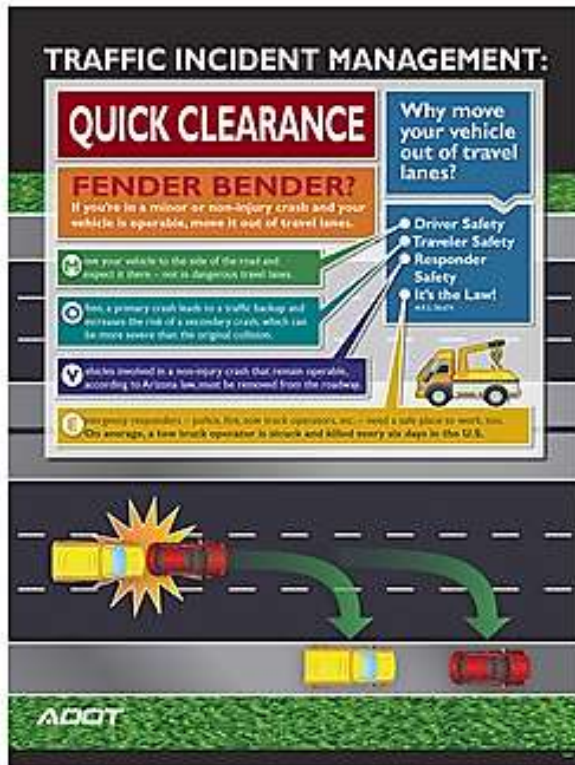
"We're working very hard to get Arizonans out of line and safely on the road, and part of that is letting people know it's okay to keep an old license plate instead of taking time out of a busy day to go to an MVD office," said MVD Stakeholder Relations Manager Jennifer Bowser-Richards. "The only exception occurs if a plate is mutilated or illegible. In that case, the law requires a vehicle owner to get a new plate," she noted.

She added, "Customers do have the option of transferring their current plate when they buy a different vehicle, but quite often if it involves merely a standard plate, people will just want to get rid of it. We want to make sure they know an office visit isn't needed to do that. We also urge people who may not want to keep a plate to put it in their recycling bin as opposed to simply throwing it in the trash."

In a minor crash? Move your car out of travel lanes

Arizona marks National Traffic Incident Management Awareness Week



PHOENIX – If you have the misfortune to be involved in a non-injury fender bender on a freeway, do not leave your car stopped in travel lanes, while you circle the vehicle taking photos of dents and dings from dozens of angles and waiting for a forensics team to arrive and piece together the cause of the collision.

That's not safe and they're not coming.

If you find yourself in this situation move your vehicle to the shoulder where you can safely exchange information with the other driver, inspect your vehicle for damage and wait for law enforcement to arrive. This is called “[Quick Clearance](#)” and is a traffic incident management strategy that keeps motorists safe and traffic moving.

During [National Traffic Incident Management \(TIM\) Awareness Week](#) (Nov. 11-17), the Arizona Department of Transportation, Arizona Department of Public Safety and other traffic-safety stakeholders are providing the traveling public with TIM tips. In addition, motorists will see TIM-related safety messages on overhead signs and on social media this week.

“Not only do TIM techniques keep traffic moving as efficiently and smoothly as possible,” said Derek Amson, ADOT’s Traffic Management Group manager, “they make it safer for those involved in the incident, safer for those responding to the incident and safer for the motorists traveling near the incident.”

Nearly 350 vehicle crashes occur every day in Arizona and most will be visited by emergency responders, which can include law enforcement, fire departments, medical services, transportation crews and tow trucks. Different responders have different duties on scene – some tend to victims and others gather information about the incident, while others remove damaged vehicles and clear space to make travel safer for other motorists – but all are practicing TIM techniques.

“TIM strategies are used by first responders on a daily basis to keep motorists safe on Arizona’s roadways, while reducing traffic congestion that often causes secondary collisions,” said Lt. Col. Wayne Webb of the Arizona Department of Public Safety’s Highway Patrol Division.

While responders employ a variety of TIM strategies that keep motorists safe and traffic moving efficiently, the public plays a role,

too. First, motorists can practice “Quick Clearance,” a [state law](#) that requires a driver involved in a minor crash without injuries to remove their vehicle from the roadway if it is operable and can be moved safely. In addition to moving vehicles from the roadway to increase safety, Arizona’s “[Move Over](#)” law requires motorists to move over one lane – or slow down if it’s not safe to change lanes – when approaching any vehicle with flashing lights pulled to the side of a road or highway.

Giving responders space to work can be a life-saving action, said Angela Barnett, Executive Director of the Arizona Professional Towing and Recovery Association. On average, one tow truck operator is struck and killed every six days in the United States, according to national crash statistics.

“Give us room to do our jobs,” Barnett said. “When you see an incident or flashing lights ahead, please pay attention and slow down. It’s real life out there and we all want to go home at the end of the day.”

Remember, if you are involved in a crash, the first action to take is to make sure you and occupants in your vehicle are OK. Then, if your vehicle is operable, move to the emergency shoulder, median or exit the highway and call 911. Stay out of travel lanes, be alert and watch approaching traffic. Never leave the scene of a crash.

BLIGHT AND ZONING LAWS

STRUCTURES: The maintenance of a home is the responsibility of the property owner. Any wood, siding, shingles, roof covering, railings, fences, walls, ceilings, porches, doors, windows, screens and other exterior parts of any structure on the property must be maintained in weather tight, sound condition and in good repair. The property owner is responsible for making sure there are no doors or windows left open and not secure to the outside. *FOR HELP call the Preservation Division of the Neighborhood Services Dept. at 602-495-0700 to see if you qualify for a free Grant!*

OUTDOOR STORAGE: All outside storage that can be seen from the street should be inside sheds or cabinets. Items should not be set in car ports in view of the street. Please use enclosed areas or backyards.

JUNK, TRASH & DEBRIS: Junk, trash and debris cannot be left in the yard or car port and must be properly disposed of. This includes junk auto parts, appliances, furniture, building and/or landscaping material, trash such as discarded papers, cardboard, plastics, etc. including tree trimmings and fallen limbs or any other items that appear to have been discarded. The only exception is during the Bulk Trash Collection weeks four times a year.

PARKING: Parking is only permitted for passenger cars and motorcycles on residential streets, on driveways or in garages. A driveway or parking area must be constructed with an approved dust free parking surface. The stone must be 1/4 - 3/4 in size with a permanent border holding it in. 1/4 minus size stone is not allowed for parking. There are limits to the amount of front yard area that can be used for parking. Only 35% of the front yard may be converted to driveway or dust free parking.

GRASS AND WEEDS: Grass and weeds must not be allowed to grow over 6 inches high due to fire hazard, allowing the weeds to go to seed and spreading throughout the neighborhood and insect infestation.

ELIMINATE GRAFFITI: Keeping the neighborhood graffiti free is something we can all do. If there is graffiti on your property, please remove it as soon as possible. The Graffiti Busters Program provides paint, supplies and training to assist groups with eliminating graffiti. The City will also remove the graffiti from private property with written permission from the property owner. Call 602-495-7014.

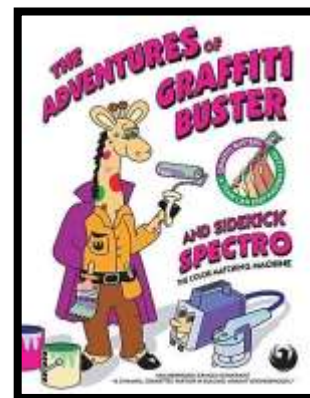

Those who successfully complete the training will be given a city identification, uniform, and resources to help carry out their volunteer assignments.

There are two levels to the BBVP, the Blight Buster and Blight Buster Leader. The Blight Buster works alone or in small groups. Their primary duties are to report illegal signs, remove graffiti, and to help out on big projects. The Blight Buster Leader is reserved for the more involved volunteer. They will receive the training and knowledge on how to become an effective leader for their community, learning how to recruit and manage volunteers. They will conduct anti-graffiti presentations to educate our community and youth on the negative effects graffiti has on our economy, and will also work one on one with residents in need, solving blight issues in their own neighborhood. 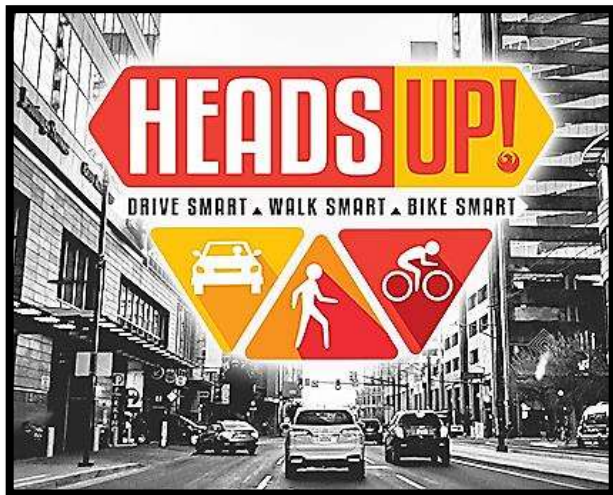

VIRTUAL BLOCK WATCH

Virtual Block Watch is one of the Phoenix Police Department's contemporary crime prevention and investigation tools that showcases our partnership with the community. Virtual Block Watch utilizes your security cameras to help solve crime. This exciting new program is now live and like all new programs, there are always new questions. Officer Martin took the time to answer these questions.

Q: How will Virtual Block Watch assist the Phoenix Police Department?

A: VBW will assist the PPD by collaborating with the community efforts to retain the theory of "being the eyes and ears" for a safer neighborhood. The recorded video will be an additional document/digital evidence of the crime for prosecution.

Q: What type of security/computer system is required in order to participate?

A: A DVR with a 30 day retention capability is preferred. This is usually a 1TB of storage capacity. It is recommended that the camera's are at a resolution of 1080p for a clearer picture but a 720p system can still be registered with Virtual Block Watch.

Q: Do you recommend any specific security/computer or camera system?

A: This will be completely up to the homeowners discretion (cost, resolution and availability of system) with the functionality and comfort level of the purchase.

Q: Does the Police Department have remote access to my security/computer system?

A: NO. Virtual Block Watch **will not** have any type of streaming capabilities or live feed from your CCTV system. The PPD will have the address of the registered system along with the locations of the camera placement.

Q: If my security system captures a criminal or crime, will I be required to testify in court?

A: NO. Once the PPD captures/copies the portion of video needed for prosecution, Forensic Imaging Tech (a city of phoenix representative) will testify on the digital evidence.

www.bolocop.com is web-based delivery system built by law enforcement to be used by law enforcement to provide direct communication to businesses and community members. The service is free and there will never be a cost associated with using or receiving BOLO/ALERTS!

Simply go to www.bolocop.com and register for the alerts. You can choose alerts for the state, a city or just your zip code

You can help police solve crimes in your community if you're willing to "BOLO" (Be On the Look Out). An easy way to do this is to register at BOLOCop.com, a web-based communication program that will send you alerts from law enforcement agencies seeking the public's help on a range of public safety issues, including locating missing persons, identifying probation violation offenders, and recovering stolen property. The service also distributes information about crime trends that may be impacting your neighborhood.

Created in 2012 by Gilbert Police Crime Prevention Officer Vickie Owen and website developer Steven Mueller, BOLO Cop is used by hundreds of federal and state law enforcement officials to distribute critical police information in a variety of ways to individuals and businesses. The site will soon add a national registry known as the "Silver Directory" which allows members of the public to add information about a loved one suffering from dementia which can be used by police to find the individual's home should they be found or if they need to activate a Silver Alert.

BOLO Cop had its origins in a fax-based service started by Peggy and Paul Secaur in 1990. After Paul received a business fax that helped him and police apprehend a purse thief in the building he worked in, Paul and Peggy got the idea for Fax Net 1 and started sharing faxes with neighboring businesses about crimes in the area. Within weeks of launching the service, police were able to catch a bank robber, break up a counterfeit ring, locate an elderly man suffering from dementia and divert an attempted rapist.

If you visit the website for the Federal Trade Commission www.ftc.gov and go to Publications (type publications in the search bar) you should be able to locate approximately 187 different FREE publications on all types of different topics. This may be a good resource for community information without the burden of paying for printing.

The **Do Not Call Registry** accepts registrations from both cell phones and land lines. To **register** by telephone, call 1-888-382-1222 (TTY: 1-866-290-4236). You must **call** from the phone number that you want to **register**. To **register** online (donotcall.gov), you will have to respond to a confirmation email.
